DEAR PATRONS AND FRIENDS...

From the Desk of the President

Humanity, period.

We — the people involved in charitable work — spend a vast amount of time working on our mission, goals, and strategies. We undertake projects dealing in Education, Women Empowerment, Healthcare, and Sanitation & Hygiene with pride; and we communicate efficiently to achieve the best results across all of our programs.

However, after spending 35 years in humanitarian work, I arrived at a simple conclusion when we heard that 25,000+ people were forced from their homes after heavy rain and flooding in North Gujarat. We called an emergency meeting to prepare a rescue plan towards our Phase 1 Goal: "Immediate Help". That, simply, is humanity. When there is a crisis threatening lives, we drop all individual philosophies in pursuit of one common goal: To protect the well-being of humans.

The response team, consisting of management, experienced humanitarians, and our members who have in-depth knowledge of North Gujarat, was called in to create a strategy to assist affected people immediately. The team rolled up their sleeves, gathered information, and created a plan — all within 48 hours.

Our goal was established: To provide 1,000 families with basic survival items in one week. We approved a fund of \$30,000 and gave a four-member sub-committee the responsibility to complete the task in few days. After research and due diligence, they finalized the operation and agreed to work with four partners in India who had volunteers on the ground, to ensure help reached those families without delay. In one week, our mission was accomplished. BRAVO!

This was our 15th post-disaster relief effort. (The first was the Bhopal Disaster relief, three decades ago.) Because every disaster is unique, each requires uniquely tailored relief efforts. Dealing with the 2004 Indian Ocean Tsunami, for instance, was quite different than dealing with the 2001 Gujarat Earthquake. No matter the circumstances, we have taken the best possible actions yielding maximum results.

I am proud to say that our members, volunteers, and staff are very professional. They are well-equipped with knowledge and training to deal with disaster relief work

efficiently so that useful help reaches victims as quickly as possible and with the best possible outcomes.

We will continue to monitor the situation in North Gujarat and decide if we should undertake projects in Phase 2 (stopgap) and/or Phase 3 (long-term rehabilitation). Be assured that this work will not compromise our other efforts. Disaster relief work does not permit us to divert from our Signature Projects; it is not an either/or situation. Our core activities in Women Empowerment, Education, Healthcare, and Sanitation & Hygiene — which are making significant progress, as you'll see in the following pages of this book — will continue uninterrupted.

For more on our accomplishments over the past 35 years, I invite you to review our Timeline (pp. 36-37). I am sure you will join me in taking pride in our journey.

You all have been very generous over the past many years. You are essential partners and teammates in our fight for humanity. In past crises, we have joined together. I am confident that our combined generosity and dedication will not only take us out of current challenges posed by natural disasters, but will also advance our ongoing commitment to improving lives.

Humanity will prevail.

DISASTER RELIEF

Emergency Aid for Flood Victims

When a disaster strikes — such as a flood or earthquake — we believe it is the moral obligation of organizations like Share & Care Foundation to rise up and help. Since our founding 35 years ago, we have provided invaluable support to victims of numerous disasters in India and the U.S.

2017 Gujarat Floods

Most recently, the Disaster Relief Committee responded to the July 2017 floods in the Indian state of Gujarat. Catastrophic floods destroyed homes, submerged farmland and cattle, and displaced thousands of families. In response to this ongoing disaster, the foundation's Board of Trustees approved an immediate release of \$30,000 to provide relief in some of the most heavily affected areas of the state. These funds equip hundreds of families with survival kits, basic medical aid, and drinking water, which we are currently distributing with the help of four local, reputable NGOs.

Banaskantha and Sabarkantha

In the Banaskantha and Sabarkantha districts, we assisted in organizing the distribution of 500 survival kits. Traveling on foot, a team of eight relief workers visited multiple villages, where they met with local leaders and social workers to assess the damage and to distribute kits. Our efforts in these areas also focus on providing drinking water, fodder for cattle, personal hygiene items, and clean-up for schools and childcare centers.

Deesa and Palanpur

In the Deesa and Palanpur areas of northern Gujarat, we helped distribute ration kits for more

than 350 families. Each of these kits contains a stove, grains, tea leaves, spices, and eating utensils.

Also in Deesa — as well as in Banaskantha and southern Rajasthan — we helped deliver kits containing clothes, toothbrushes, and basic food items. The kits distributed in these areas will help approximately 1,000 families.

Radhanpur

In the Radhanpur area, we are assisting in the distribution of mosquito nets and grocery kits. It is estimated that each grocery kit will feed a family of four for at least two weeks.

Keeping the Help Coming

To continue our disaster relief efforts, we need your generous support.

Our goal is to raise a total of \$155,000 in funds for the victims of the catastrophic Gujarat floods. Your generous contribution will make a huge difference in the lives of the people affected by this tragedy.

Immediate Relief: \$30,000 (in progress)

As described, these funds are supplying food rations and basic necessities for displaced families.

Medium- to Long-Term Relief: \$125,000

These funds will support the restoration of schools and primary health centers, as well as the construction of temporary shelters for families. Provisions of potable water and sanitation efforts are also under consideration.

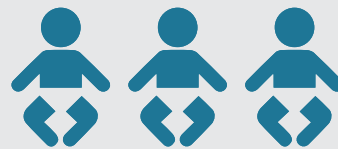
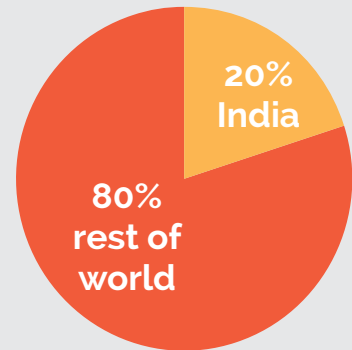

HEALTHCARE 2 UNREACHED



Bringing Healthcare to the *Unreachable*

The Share & Care Foundation continues to promote self-sustainable development of education and health infrastructure in northwestern Rajasthan's rural Khichan-Phalodi area, located in Jodhpur district. Large parts of Jodhpur district fall under the area of the Thar Desert, a large, arid region is characterized by adverse climatic conditions and chronic droughts.

Working with a local NGO, Share & Care is delivering much-needed healthcare to villagers who require a combination of education, public sanitation, and regular access to healthcare providers and facilities. We've been in Kerla village since 2010/2011, and started the same program in Suwap village (in the same district) in 2015. **The yearly cost per patient is less than \$10.**

A lack of basic amenities make life extremely challenging, especially for women and girls. Amidst this, the health conditions in the remote villages are horrendous. It is reflected in high rates of disease, malnutrition, mortality, and morbidity rates. Poor health hampers educational opportunities for girls, and female illiteracy is high. It is a very difficult area with little socio-economic development.

We have also embarked on an Improving Child and Mother Survival project with another local NGO, with the objective of reducing infant and maternal mortality in three Jodhpur district villages.

DELIVERING HEALTHCARE, ONE VILLAGE AT A TIME

Kerla Village: 2010/2011– Present

Kerla, located in the middle of the Thar Desert, has no roads, no transportation facilities, no electricity, no water, and, prior to Share & Care's involvement, no healthcare system.



The nearest health facility for any kind of medical aid, even for dressing a wound or providing injections, was 18 km away in the village of Aau.

Our Impact

Our work began with renovation of a building that had been originally constructed by the local government, but had never seen use. In great disrepair, it was ready to collapse. The health center had never been occupied by either a doctor or nurse.

By the start of 2012, the center was completely renovated and has been fully capable of providing preventive therapeutic and rehabilitation services. A sub-center provides for examinations and necessary treatments that include medicines, vaccinations, immunizations, and nutritional supplements. Senior physicians run weekly clinics, and an auxiliary

nurse midwife and a village-level healthcare worker are present day and night, and provide all required emergency services. Additionally:

A total of **16,520 women, men, and children** were seen between December 2011 and 2016.

- The village's infant mortality rate (< 1 yr.) went from 77 per 1,000 births to **zero per 1,000** in the first year and has remained consistent for the last four years.

- The number of women seeking treatment for pelvic inflammation — very common among women in the area — went down from around 22–32 per week in 2012, to **only 1–4 per week** currently.
- Instances of human whipworm (an infection in the large intestine related to poor hygiene) are very common in the area, but **no longer result in malnutrition** due to timely treatment.

IN THEIR OWN WORDS

Kerla Resident Urges Share & Care to Continue Program

With no transportation facility in this village to take treatment, our life was difficult. Treatment was irregular, and we had much suffering. Today, doctors are coming regularly every week, without interruption. The villagers request Share & Care to please continue their support. We are not in a position to afford healthcare, and the government does not provide a required facility. Please continue to favor us as you have done over the last four years, to keep the women and children of Kerla healthy.

- Skin diseases such as scabies and ringworm, also very common, are treated readily, **preventing them from spreading** throughout the population.
- Other common ailments, such as malnutrition anemia and hypocalcaemia (low calcium), and chronic diseases, such as asthma, diabetes, and COPD, are treated during weekly visits, thus preventing additional health issues and **improving quality of life.**

Suwap Village: 2015–Present

The village health conditions were perilous. Because water and electricity are scarce, Suwap villagers live in a small conglomeration of huts without toilets. A doctor had never visited the location, and no other healthcare workers were available. The infant mortality rate was 79.66% and immunization rates and antenatal care for women was almost nonexistent. The nearest community center to Suwap was 80 km away in Phalodi Town, and the nearest primary health center was located 17 km away in Aau.

Our Impact

Share & Care became involved in 2015 to help form a healthcare program. By 2016, an abandoned health center was completely renovated, including a waiting area, a small laboratory, a birthing facility, a well-equipped residential facility for nursing staff, underground water storage, and indoor in-patient care.

For the first half of 2017:

- A total of **1,840 women, men, and children** were seen between January and July 2017.
- 32 infants (< 1 yr.) and 15 children (1–5 yrs.) **received vaccinations.**
- 38 pregnant women **received antenatal care and immunizations.**
- **33 women** visited for the first time, and 13 for the second time, and were immunized.
- **25 patients** had laboratory tests related to malaria, pregnancy, and levels of hemoglobin, blood sugar, etc.

Results are encouraging and are comparable to that of Kerla, whose

four-year results indicate to us that an investment in infrastructure, a full-time experienced nursing staff, and a regular weekly visit of a senior doctor can make a tremendous difference in the lives of villagers, including significant decreases in child and mother mortality and morbidity.

A Real Life Story

A Family Learns the Truth, Just in Time

In May this year, 20-year old Madina — eight-months pregnant with her first child — traveled a great distance with her parents to visit the Suwap Health Sub Center. This was Madina's first visit to a health facility, and she had come to seek help for symptoms of coughing and feeling dizzy. Her face was puffy and she had difficulty breathing; she had edema (an often painful, abnormal accumulation of fluid under the skin that manifests itself as swelling) and appeared anemic. A blood work-up confirmed she had barely one-fourth the normal levels of hemoglobin: anemia.

The consulting physician explained that both her life and the life of her baby were in danger. Her parents were surprised to hear how sick she was, they had only brought her to the center because of her recent symptoms.

Within two days they rushed Madina to a hospital in Khichan where she had a transfusion. Still not understanding the severity of the problem, another two days later she received a second transfusion. The following night she went into labor and, at 3 a.m., she gave birth to a baby girl.

HEALTHCARE 2 UNREACHED



Today, both mother and baby are happy and thankful. The outcome could have been much different. Thankfully, the resurrected Suwap Health Sub Center was there for immediate help, plus a hassle-free referral for affordable treatment.

Improving Child and Mother Survival — A Holistic Approach

About a year ago, we embarked on the Improving Child and Mother Survival project, with the objective of reducing infant and maternal mortality in three Jodhpur district villages. The project affects about 600 women, 1,200, children, and 400 adolescents through education, improved nutrition, and improved collaboration with government healthcare.

Goals

Over the course of three years, Share & Care will help implement a number of health interventions, including training village health workers and implementing a specialized nutrition education program for women and adolescent girls and boys.

In addition, antenatal care services will be provided and arid horticulture units will be set up to support nutrition. The project also has a learning and research component that will allow progress to be measured against baseline data and final evaluations, and used to improve beneficial health behaviors within the communities.

We believe that community-based holistic interventions can make a significant contribution in reducing child and mother mortality and in creating healthy societies across India. So,

while the project directly benefits more than 2,200 women and adolescents in the three villages, the secondary goal is to promote the replication of the program in many more villages.

Suwap Resident Thanks Share & Care for Responsiveness

We receive a physician visit to our center every Tuesday, and full-time nursing staff stay in the center. Transportation is provided to vaccinate all children, as residences are scattered far apart. The doctor also provides us with referral services and sends us to the required specialized center so that we can get free and affordable services. Improving Sanitary Conditions: Building Dignity and a Healthier Lifestyle

770 New Toilets in 7 Villages Create a Welcome Change

The Share & Care Foundation has been a leader in improving the dignity, health, and wellness of women, children, and families living in poverty by constructing 770 toilets and improving poor sanitary conditions overall in seven rural Gujarat villages: Alindra, Chadotar, Vanzarapura, Ganeshpura, Bhutedi, Dangarva, and Fudeda.

The project combines new construction of low-cost/high-quality toilets with education on both their use and other daily health and hygiene practices. Specifically, the women of the seven villages were among the worthiest beneficiaries. In the past, they would often wait

through the long days until the cover of night provided much-needed protection against the embarrassment and shame — and dangers — of relieving themselves in the open. The village residents had used the open areas around nearby ponds, streets, and agricultural fields to relieve themselves—polluting land, water, air, and food production.

A Real Measure of Success

Change was made evident within one year: Residents have stopped open defecation by using the toilets, and little to no human waste is seen out in the open. We have heard many reports of people noticing this remarkable change, as well as a shift toward adopting positive sanitation and hygiene habits. Also, the new toilets and education mean girls and women are now able to avoid the risk of assault, rape, and harassment, while living a healthier — and far more comfortable — lifestyle.

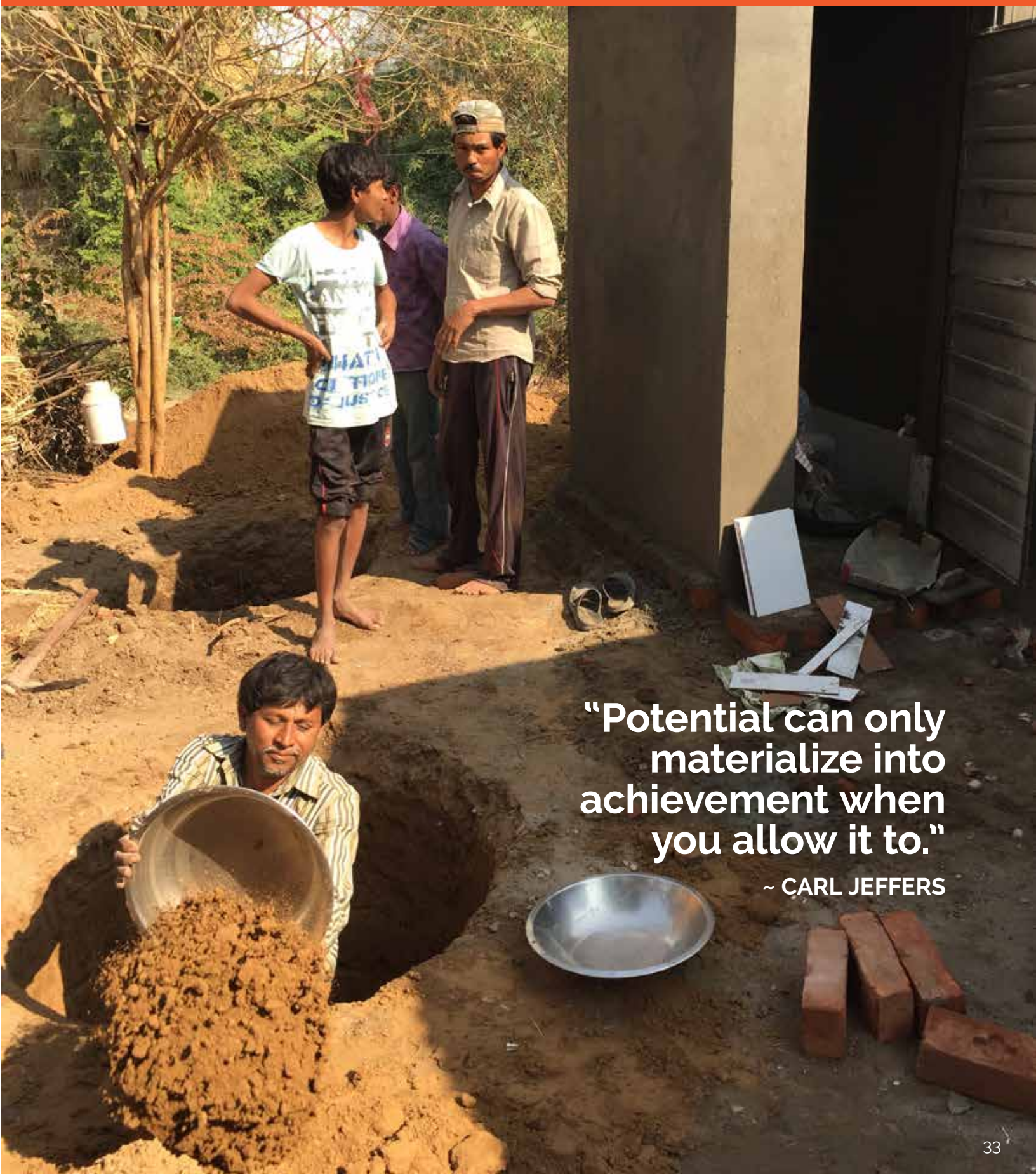
Within 14 months the project achieved measurable and qualitative results, including;

- Building trusting relationships with village leaders, who assumed a vested-interest in maintaining the project's ongoing success.
- Teaching local masons new skills on sanitary facility construction and maintenance; building the local economies, and reducing dependence on external help.
- Demonstrating sanitary awareness through three-day programs where the karykarta (staff) enjoyed an intense, yet loving teaching experience with village residents.

IN THEIR OWN WORDS

The team made three follow-up visits to each village to see how the beneficiaries were caring for their new toilets. In the overwhelming majority of cases, we saw that they were treating them with a great deal of care and respect, which gave us confidence that no further visits were required. We can say, without a doubt, that the project has had a positive impact, and is positioned for future success.

Here we share responses of the villagers themselves:



Chauhan Babaubhai Ghudabhai

I have two physically challenged family members. My daughter Laxmi is completely dependent upon me and Hansaben, my daughter-in-law, is blind. Having to trek some distance for them to use the toilet with my assistance had been challenging. After receiving our toilet, I am relieved of this burden since both are now self-sufficient. When my daughters expressed their happiness about the new conditions, they were spreading blessings to all who contributed to making this change in our village.



Chandrikaben Patni Govindbhai

I study in 9th Std. and always felt shame when having to go outside, in the open, to use the toilet in the morning and evening. It was particularly stressful during time of menses. Now, I'm using my toilet without any fear or stress.



Vanzara Bhemaji Nanaji

When I lost my leg in a road accident I became handicapped. I used to need at least one person's support to use the outside toilet. It was humiliating. When I took a small bucket of water, no one was ready to come with me and people would run away, making me feel bad. Now, I have my own toilet at my house and I'm feeling very good.

NIRMAL VILLAGE PROGRAM

Sri Kantibhai L. Bhandva, Assistant Teacher, Chatodar Primary School

Only a year ago, people living behind our school used our compound wall and surroundings to relieve themselves. Students would arrive for class each day disgusted by the odor and appearance of human waste. That was how they began their day. It has changed completely. We send our thanks to the Share & Care Foundation for being a supportive hand to our village people by providing toilet facilities.

Balaji Vanzara, Vanzarapura

I work as a social leader in our community. We essentially live a nomadic life and set-

tled near the passage of the Sabarmati River. Before the toilets were constructed, we were forced to use this risky area, in the open. We have seen a change from the smallest kids to our elders, everyone is using their toilet without fear. We send our thanks to the Share & Care Foundation and our local volunteers for such valuable support.

Maheshbhai, President, Palanpur Taluka Panchayat and Bhutedi

We always felt worried about people's daily practice of open defecation. Nobody had the means to build their own toilet that cost more than Rs. 25,000 [approx. \$390 USD], which can be a half year of someone's annual earnings. The work by the Share & Care Foundation and our village has benefited us by adding a total of 88 toilets. Almost all beneficiaries are using them with love and care. Thanks.

Timeline: Celebrating 35 Years

1983

How it All Began | Share & Care sends 2,000 pounds of donated used clothing to India. | Our first fund raising program raises \$15,000

1984

The Bhopal gas leak, considered the world's worst industrial disaster, occurs the night of December 2-3. Relief efforts are extraordinary – including \$60,000 in assistance from Share & Care's first comprehensive crisis response.

1985

Between 1984 and 2007, \$15,359,000 worth of medical equipment is sent to rural villages as part of the lifesaving "Used Medical Equipment Initiative."

1989

Working with SEWA Rural, an NGO based in Jhagadia (Bharuch district, Gujarat), a \$110,000 investment establishes a healthcare training center as a resource to acquire basic knowledge about effective patient care. 5,600 paramedical workers are trained.

1988

Four rural villages are "adopted," integrating support in health, education, and welfare. Over 4,000 farmers become self-sufficient with a total investment of \$36,000.

1987

Aid and supplies are provided in response to a dangerous drought in Gujarat. Over 500 water wells are built with a total investment of \$46,850.

1986

A mass appeal is conducted to "Sponsor a Student" – an initiative to bring educational opportunities to India's disadvantaged youth. Over 35,000 students are sponsored.

1990

Working with Nandigram Trust, an NGO based in Dharampur (Valsad district, Gujarat) working with India's tribal population, a \$40,000 investment is made toward basic education and primary healthcare.

1991

Working with the Anjali Society for Rural Health & Development, an NGO based in Ranasan (Sabarkantha district, Gujarat), a \$121,000 investment builds our first 30-bed hospital in Ranasan. More than 32,000 rural people receive free medical attention. The hospital is still in operation today.

1992

Pilot project "English as a Second Language" covers three schools in North Bergen, NJ. The \$16,000 investment helps new U.S. immigrants from India to learn English. | "Experiment in Self-Help" – our novel approach to stop job-seekers migrating to big cities for jobs – is established in West Bengal.

1995

An ambulance and medical equipment, for a total investment of \$106,399, are provided to Narayan Seva Sanstha, an NGO based in Rajasthan. | Share & Care is approved and listed under Indo U.S. Bilateral Agreement.

1994

"School on Wheels" is established to take learning onto rural roads. It is later donated to the Sister Nivedita School in Rajkot, Gujarat. | An \$18,000 grant is provided for 60,000 students in 30 villages.

1993

Working with the Dharamshila Cancer Foundation, a \$200,000 investment builds North India's first state-of-the-art comprehensive cancer care and research center in New Delhi. | The 6.2 magnitude Latur earthquake in Maharashtra occurs on September 30, and is the largest earthquake to be felt in India since its Independence. | Immediate relief is provided including food, medicine, and daily required items. | Assistance of \$150,000 is provided for rehab projects, schools, and clinics.

1996

Scholarships totaling \$160,500 are set up for promising U.S.-based students. 160 students attend college, including one medical student.

1997

A \$1.4 million investment of 106 hemodialysis machines are sent to 35 charitable hospitals in India. Over the next 10 years, 600,000 patients with kidney disease are treated.

1998

The Gujarat cyclone hits June 1 and devastates the coastal town of Kutch with winds up to 120 mph and 25-foot tidal waves. Blankets, food, and clothing are provided to help with relief efforts.

1999

Lucent Technologies Foundation bestows Share & Care with a \$500,000 multiyear corporate grant for far-reaching youth development initiatives in India.

2014

A new Signature Program is launched: Women Empowerment. That same year, "Shades of Shakti," a celebration of 17 U.S.-based South Asian women, is honored. | Share & Care launches a new website.

2015

The 7.8 magnitude Nepal earthquake occurs on April 25. Funding is provided for Nepal Earthquake Disaster Relief programs. | A new Signature Program is launched: Nirmal Village, a program designed to create awareness of sanitation & hygiene practices in rural India.

2016

Educate 2 Graduate celebrates 10 years of reaching out and helping 1,289 worthy scholars attend college. | The fifth Health and Wellness Fair is held in northern New Jersey. | Through our Nirmal Village Program, we built indoor toilets and provided sanitation & hygiene training and education for 770 families living in remote villages of Gujarat.

2017

The Gujarat flood occurs in July. Funding is provided for Gujarat Flood Disaster Relief programs. Total grants exceed \$72 million in cash and kind since inception

2013

The 5.1 magnitude Uttarakhand earthquake occurs on February 6. Funding is provided for Uttarakhand Earthquake Disaster Relief programs. | A new Signature Program is launched: Educate 2 Success, a program to keep children in school, supports 1,000 economically underprivileged school children in the northeast region of India.

2012

The first Health and Wellness Fair is held in northern New Jersey and provides free flu shots and screening for blood pressure, diabetes, cholesterol, and BMI to over 200 participants. | A new Signature Program is launched: Healthcare 2 Unreached, a basic primary healthcare program delivered via a multipurpose medical mobile van that travels to remote villages of Rajasthan.

2011

The "Ambassador Program" is launched to encourage and motivate youth to help spread our mission and vision.

2010

Share & Care's "Science on Wheels" bus – a traveling school lab – provides science learning to students in remote rural schools.

2007

Share & Care's 25th Anniversary! Total grants over the 25-year journey exceed \$50 million. | The "Young Adult Group" is developed to involve the next generation of young professionals. | The first Signature Program is launched: Educate 2 Graduate, a loan scholarship program for brilliant but economically challenged students to pursue graduate studies in medical and IT fields. | The first Share & Care chapter is launched in North Carolina. | A three-day medical checkup and wellness camp, conducted by physicians from the U.S., is launched in Bhimora (Surendranagar district, Gujarat) in partnership with a local NGO.

2008

An ambitious integrated development program – a strategic plan of excellence in educating and empowering women to secure future independence for their families – is launched.

2009

50 students enroll in the Educate 2 Graduate Signature Program.

2006

Two major initiatives with a focus on long-term change for the future of women and youth in India are introduced: A "Women Empowerment" and "Youth Development" program are both carefully defined as banner initiatives for the organization going forward. | Three-year programs are developed to improve the quality of education. \$200,000 is provided to cover 10,000 students in 2006 and 2007.

2005

Hurricane Katrina occurs in August in Louisiana, USA. Share & Care responds with humanitarian donations totaling \$12,500.

2004

The Indian Ocean earthquake occurs the morning of December 26, followed by a series of tsunamis over the next seven hours. An estimated 3 million people are affected by this epic-scale effect of an offshore earthquake. Assistance of \$350,000 is provided for shelter and sustenance, and to help restore livelihoods and hope to the survivors in Southern India and Sri Lanka.

2000

Agilent Technologies Foundation grants \$63,000 to Share & Care to institute a mother and child project at the Dr. M.L. Dhawale Memorial Trust in Delhi.

2001

The 7.7 magnitude Gujarat earthquake occurs on January 26. Over \$5 million in cash and kind is provided for the relief and rehabilitation of survivors.

2002

An internship program is established at Yale University for students to volunteer their services to Share & Care's NGO partners in India.

2003

Grants totaling \$239,000 are provided to build the fully equipped Cardiac Care Unit in Cambay (aka Khambhat, Anand district, Gujarat).

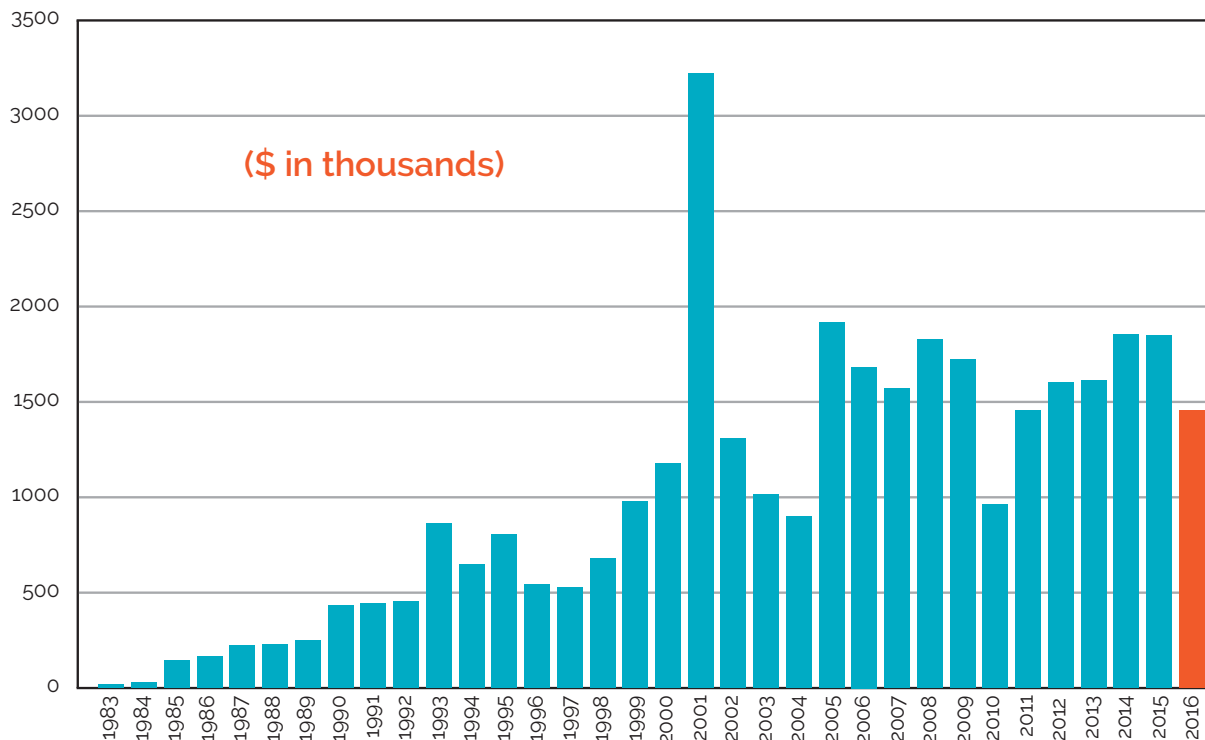

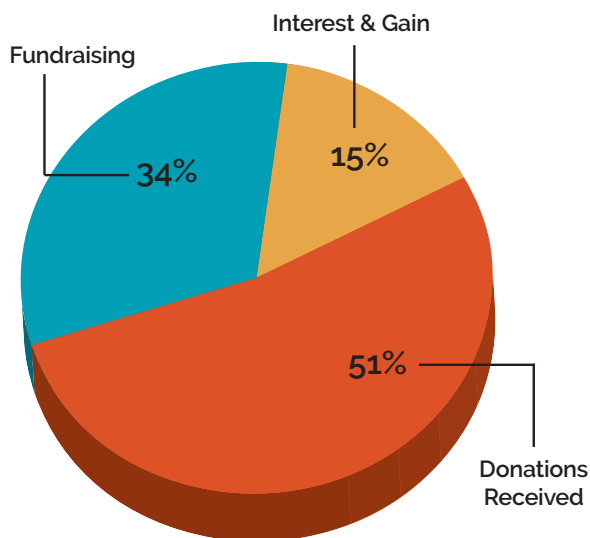

Total Cash Donations



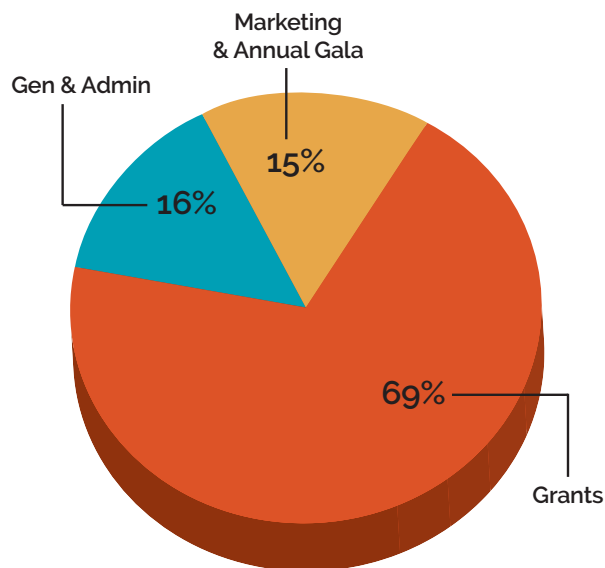

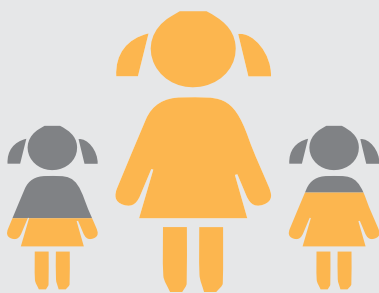


OUR MISSION

To empower women by creating lasting, systemic changes in society that will ensure optimal gender equality and equity, personal safety, and opportunities to gain livelihood skills and tools for success.

PROGRAM GOALS

- 1. Empower women** with a comprehensive approach that includes education in banking, personal finance, gender equality issues, and personal safety — as well as training in livelihood skills. Provide them with resources to succeed and become self-sufficient, such as seed money to start a trade, micro loans, and market linkages. Equip them with professional tools and equipment such as sewing machines, embroidery machines, cosmetology chairs, or catering kits when applicable.
- 2. Cultivate a sense of community** by enhancing the formation and continuation of self-help groups in which empowered women help to empower others, therefore continuing to enhance gender equality and equity in the society. Self-help groups are a proven modality to help bring economic empowerment to various parts of the world.
- 3. Develop programs** in which gender equality and equity issues are addressed in society at large. Educate women about their rights within the society and create an economic environment in which there are equal opportunities for women in every sector. Grassroots programs are critical to ensuring women have opportunities not only to succeed, but also to utilize their success to empower others.
- 4. Provide personal safety education** to all school-age children. By equipping children with this knowledge, we can lower the chances of men becoming perpetrators or bystanders of violence against women. Additionally, we will continue working with NGOs to provide adult women with education about basic personal safety — including hands-on defense training about how to escape danger or fight back against violence when needed.



At SCF, we are committed to using innovative, multifaceted and evidence-based approaches to empowering women, taking into account the myriad challenges girls face seeking gender equality, equity, and opportunities.

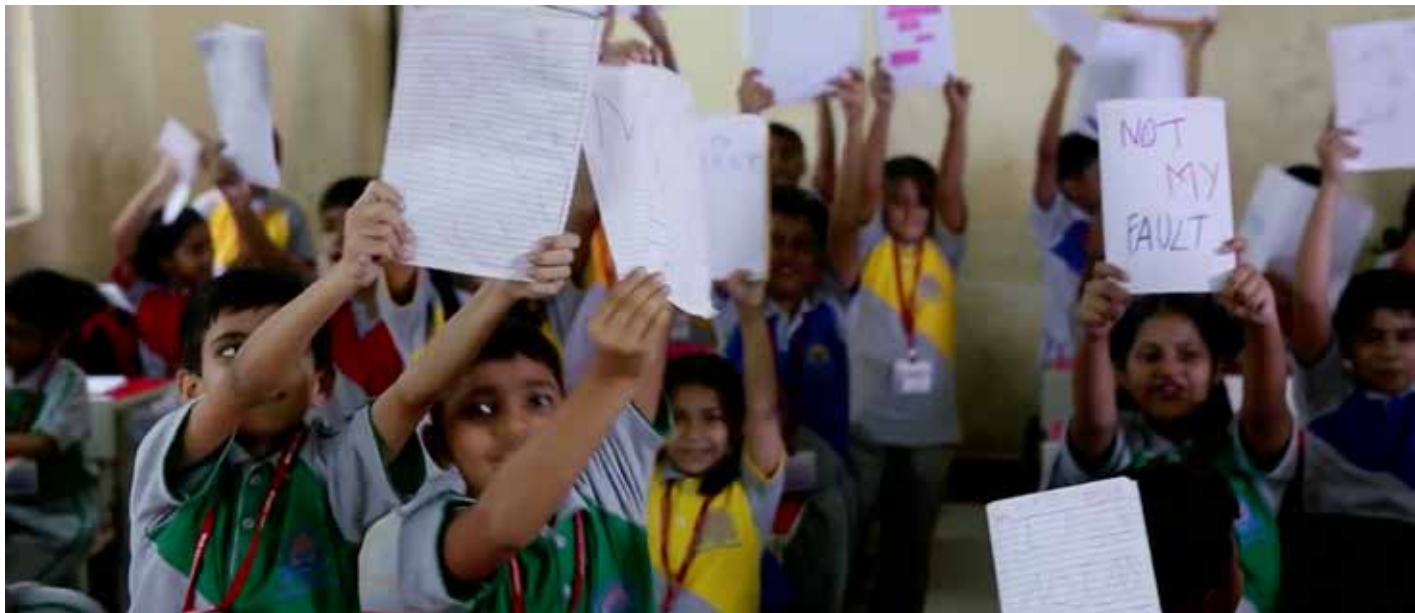

Empowerment for All: Freedom From Child Sexual Abuse



According to a 2007 National Child Abuse Study, 53% of India's children have experienced some form of sexual abuse, and 54.5% of incest rape victims are children under 18 (NCRBI 2015). Although the government and other organizations have focused on improving the quality of education and accessibility to all, the topic of sexuality remains a taboo, and there is very little done to empower children with essential life skills to keep themselves safe.

Culturally, child sexual abuse occupies a unique space where it is both recognized ("it happens to others") and denied ("it does not happen to my child or family members"). Too often, parents and caregivers lack the knowledge necessary to teach children vigilance or, in the case of violations, the understanding to support and comfort victims.

Students show off colorful signs with the message: "Not my fault." Preventing feelings of guilt is key to addressing child sexual abuse.

Addressing the Problem

Share & Care Foundation has decided to address the issue of child sexual abuse through our Women Empowerment Signature Program. We believe that when we are empowering women, we must address violence prevention and promote gender equality in addition to promoting livelihood. Providing this education at a young age, to both genders, is critical; while females are more likely to be victims, males who receive this education will be less likely to become perpetrators or bystanders of violence.

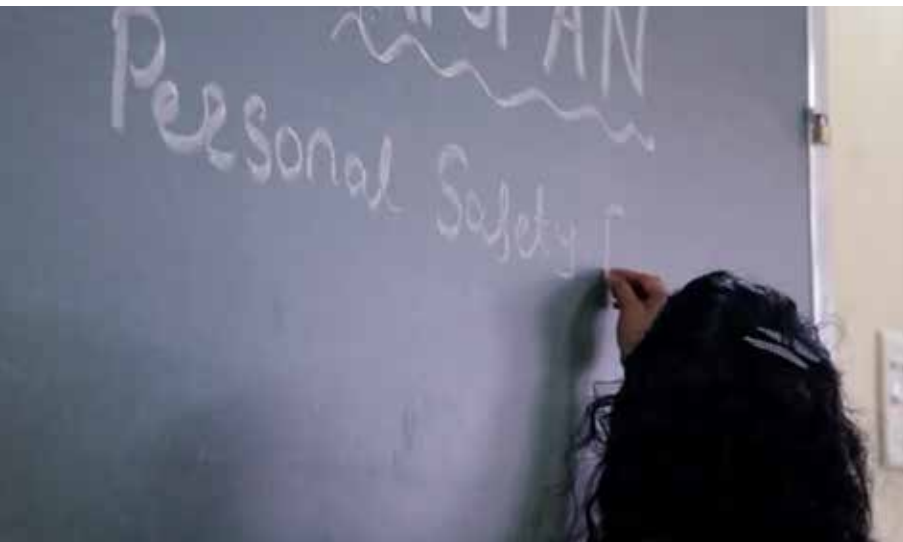
Additionally, we recognize that the beneficiaries of this program include not only children but also parents, teachers, and other members of the community.

WOMEN'S EMPOWERMENT



A Multifaceted Response

Child sexual abuse is a violation of a child's body and of the trust implicit in a caregiving relationship. Victims experience conflicting emotions — such as shock, shame, rage, confusion, and guilt — that can have a significant, lasting impact on how they see and experience the world. They may experience mental health issues such as depression, anxiety, addiction, suicidal thoughts, and/or post-traumatic stress disorder, which can continue to disrupt their lives throughout adulthood if not treated.

The negative impacts of sexual abuse call for a multifaceted response, and research shows that prevention programs and therapeutic support have the potential to reduce abuse and heal its effects. With the help of a reputed NGO, we are able to reach thousands of children, adolescents, and adults and provide them with direct services toward prevention.

These services include age-appropriate personal safety training for individuals and relevant stakeholders, long-term psychothera-

peutic support to adolescents who have been trafficked or sexually abused, and policy advocacy for systemic changes that will appropriately respond to the needs of children.

At the core of these services is the Personal Safety Education (PSE) program, which focuses on empowering children with adequate knowledge, attitudes, and skills to prevent instances of abuse as well as to seek support when such an incident has occurred. This program is conducted in privately owned and government schools, in shelter homes and orphanages, and among highly vulnerable groups of children referred by local NGOs. Counseling is provided to victims as well as to children who have indulged in sexual misbehavior, in order to prevent further offenses. Education also involves awareness-building and skills enhancement for adults such as parents, teachers, and other caregivers to create strong safety and support networks around children in their respective environments.

Our Impact

Short-Term Impact:

- 5% of children disclosed sexual abuse and received support.
- Ongoing abuse stopped, and communication channels have opened up between children and parents.
- Children have become advocates for teaching personal safety to other children.

Long-Term Impact:

- 100% of children talked about the program after attending it.
- 100% of children said they would want to attend the program again.
- 8% of children reported having faced an unsafe situation. (Among these, 90% were able to seek immediate help.)

These outcomes indicate that PSE plays a key role in the prevention and risk reduction of

abuse. Engaging in child protection with children and adults is critical, and our model educates different members of society in a way that is truly impactful. With support from generous donors, we aim to help our partner NGO expand the Personal Safety Education program to reach over a million children and 24,000 adults over the next three years.

In Their Own Words

Grade IX Student

The program taught my entire class and me the names of private body parts. They also taught us Articles [rights], which we did not know early — especially Article 34, which teaches us about the right to protection from sexual abuse. I feel it is very important for all of us to know. Nobody has ever taught us any of these things before.

Parent/Awareness Session Attendee

We are aware of this issue through the media. However, the media have a tendency to leave the viewer with negative messages, but you have addressed the issue more appropriately,

thus leaving us feeling positive and with hope at the end of the session.

School Administrator

When I was nine, I was molested by my maternal uncle, and I've lived with the guilt that it was my mistake. Following the session, I realized that it was not my fault, and I spoke up about the pain that had been silenced for so long. I called my uncle and spoke to him, and told him that what he did was wrong. Being able to do this made me feel confident. I was able to stand up without the burden of guilt on my shoulder.

Good Things Start With a Vision



With the support of caring staff and educators, our E2S beneficiaries acquire more than academic training. They also gain confidence and tools for personal growth.

Good things do indeed start with a vision. The Share & Care Foundation has always believed in empowering rural India as a vehicle for change, and have sought established NGOs to reach out to the most vulnerable in rural Indian society — specifically, women and children. Our goal is to empower the defenseless with supportive programs that are sustainable over time. The approach to provide long-term impact is based on three action items:

1. To educate.
2. To empower.
3. To equip children and families in need with opportunities for employment.

Some of the most at-risk in the target area are dropouts. Over 40% of Indian students drop out before reaching eighth grade, and the numbers in rural areas are even higher.

Share & Care supports work with children from rural, tribal, and underserved areas, and equips them with the skills to lead productive lives.

Real Stories of Student Triumphs

Namita Adhikari, Sai Centre, Mangaon
Namita passed Std. X in June 2017 with 76.80%

Namita was first enrolled in Project Anando when she was in Std. VIII. With the opportunity that Share & Care provided for her to achieve, she says that, "All my teachers have really worked hard for my academic progress as well as for my overall personality development."

Originally, Namita was shy and lacked confidence. She would often choose to remain silent in class, but now she is outgoing and even has the self-assurance to express herself on stage.

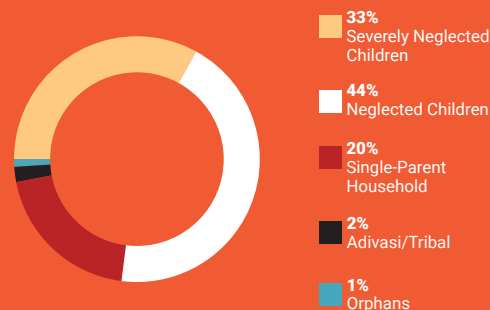

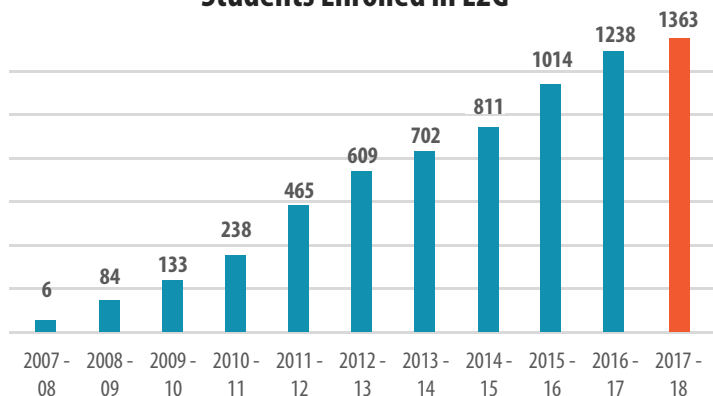

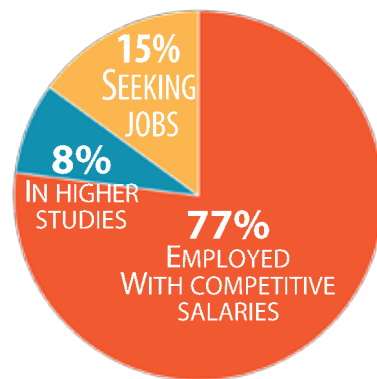

Across India, thousands of young scholars have the desire, determination, and aptitude to attain a college education — but cannot afford the cost of tuition. In many cases, these individuals come from low-income families who have faced limited access to education and, subsequently, limited employment opportunities, for generations.

The goal of our Educate 2 Graduate Signature Program is to make higher education a reality

for thousands of brilliant yet underprivileged scholars. By providing our beneficiaries with interest-free loan-scholarships, we can set these promising young adults (and their families) on a path to a secure future, free from the binds of poverty.

Together with our partner NGOs, we screen loan applicants and choose those who meet a rigid set of requirements based on aptitude, initiative, and financial need.

E2G launched in Bharuch, Gujarat, in 2007 and has since expanded to include locations in Rajkot, Gujarat (added in 2009) and Chennai, Tamil Nadu (added in 2016). To date, we have helped 1,238 scholars achieve their dreams of higher education.

We've seen over the past decade that E2G has unlimited potential for growth, as the loan-scholarship model is designed to continually add more scholars to our roster. And because our support includes not only financial assistance but also mentorship and a sense

of community, our beneficiaries often go on to become role models for their families and friends. An investment in E2G is truly an investment with unlimited returns.

If I didn't get the scholarship, I would not have

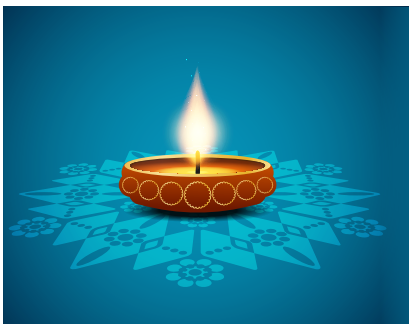
